Road safety is a target of *SDG 3 – Ensure healthy lives and promote wellbeing for all at all ages*. As we move forward in the 2020-2030 Decade of Action for Road Safety, what are we doing to halve the number of global deaths and injuries from road traffic accidents? What needs to be done over the next eight years in order to reach that target?
